NOTICE OF MEETING

The Board of Commissioners of the Port of Bay City Authority of Matagorda County, Texas, a political subdivision of the State of Texas, hereby gives notice in accordance with the Texas Government Code, section 551 et seq, that a public meeting is to be held at the office of the Authority, 1305 Seventh Street, Bay City, Texas, Thursday, December 10, 2020 at 6:30pm. AN EMERGENCY HAS BEEN DECLARED DUE TO THE COVID-19 PANDEMIC AND THE LARGE NUMBER OF CONFIRMED CASES IN MATAGORDA COUNTY, TEXAS. AS A RESULT OF THE DANGER AND RISK TO THE GENERAL PUBLIC AND THE COMMISSIONERS OF THE PORT OF BAY CITY AUTHORITY, THE COMMISSIONERS WILL PARTICIPATE IN THE MEETING THROUGH VIDEO/TELECONFERENCE AND WILL NOT BE PHYSICALLY PRESENT AT THE MEETING. THE PORT OFFICE LOCATED AT 1305 SEVENTH STREET, BAY CITY, TEXAS WILL BE OPEN TO THE GENERAL PUBLIC TO ALLOW THE GENERAL PUBLIC TO LISTEN TO THE MEETING, JOIN IN, AND PARTICIPATE IN THE VIDEO/TELECONFERENCE MEETING.  reimbursement of costs for surveying expenses incurred by the Port Authority in working toward
 establishing an AEP transmission line easement;
