The purpose of the meeting is for:

- 1. Election of officers for Port of Bay City Authority, including Chairman, Vice Chairman, and Secretary;
- 2. Action of the minutes of the regular meetings of December 9, 2021;
- 3. Presentation, approval, and ratification of bills;
- 4. Discuss and take required action on activity at the Port and Matagorda Harbor;
