The Board of Commissioners of the Port of Bay City Authority of Matagorda County, Texas, a political subdivision of the State of Texas, hereby gives notice in accordance with the <u>Texas Government Code</u>, section 551 et seq, that a public meeting is to be held at the Office of the Authority, **1305 Seventh Street, Bay City, Texas**, <u>Thursday</u>, <u>February 10</u>, <u>2022 at 6:30pm</u>. The purpose of the meeting is for:
