The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for Port of Bay City Authority from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that Port of Bay City Authority may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Port of Bay City Authority is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 21, 2022 AT 6:15 PM AT Office of the Authority, 1305 Seventh Street, Bay City, Texas 77414.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Port of Bay City Authority is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of Port of Bay City Authority at their offices or by attending the public hearing mentioned above.
